Regulations for Participation and General Regulations

The regulations for participation in the Mushroom Days 2009 are determined in the following Regulations for Participation and in the 'General Regulations' for participating in, for or with events of Libéma Exhibitions & Events B.V., hereafter to be called 'General Regulations'.

Organisation

The exhibition is organised by Libéma Exhibitions & Events B.V., hereafter to be called 'the organisers'.

Location and date

The exhibition will take place at the Brabanthallen (Langstraathal), Diezekade 2 in 's-Hertogenbosch, the Netherlands from Wednesday June 10 to Friday June 12, 2009.

Opening hours

The exhibition is open for visitors on Wednesday June 10 and Friday June 12, 2009 from 10.00 to 17.00 hours and on Thursday June 11, 2009 from 10.00 to 18.00 hours.

Floor space rental

The floor space rental fee per square meter, as described in article 5 of the 'General Regulations', is:

€ 70,- per sqm. excluding VAT and Tax.

Registration

The closing date for registration has been set on February 1st 2009 (or as long as stand space is available after this date).

Participation

Only exhibits of goods and services which are relevant to the mushroom industry are allowed.

The organisers will judge the relevance and safety of the exhibits for the mushroom industry and will also determine the amount of stands exhibiting the (same) products and services. Goods and services which have been determined as unsafe or which may show technical flaws shortly after the start of use, for the consumers or visitors of the event, as determined by a well respected and recognised research organisation, will not be allowed.

Build-up

The Brabanthallen will be open for build-up on Monday June 8 and Tuesday June 9 2009 from 08.00 to 22.00 hours. The furnishing of the standard stand constructions is allowed starting on Tuesday June 9, starting as of 12.00 hours.

Dismantling

The removal of goods, as well as the dismantling of stands is allowed on Friday June 12, between 17.30 and 22.00 hours and on Saturday June 13 between 08.00 and 12.00 hours.

Participants with standard stand construction are obligated to have cleared the stand before Friday June 12, 22.00 hours.

Payment Terms

The payment of the stand rental fee, including VAT and Tax, as described on the Exhibitor Registration Form will be due within 14 days of the date on the final allocation invoice or not later than the start of build-up of the exhibition.

Cancellation rules

In case of cancellation of participation the following payment obligations apply:

- 6 months before start of the first exhibition day, 25% of the total stand rental fee
- 4 months before start of the first exhibition day, 50% of the total stand rental fee
- 2 months before start of the first exhibition day, 75% of the total stand rental fee
- 1 month or less before start of the first exhibition day, 100% of the total stand rental fee
